NY Times: Want to Understand 2024? Look at 1948.

Americans were angry with Truman because of high prices in the aftermath of World War II, even as other economic signals looked promising.

In this article, the Slimes in-house "polling expert" **Nate Cohn** (*cough cough*) seamlessly weaves Fake News with Fake History for a "twofer" of treacherous tripe. Cohn's cunning and grotesque distortion of both the present and the past -- *at the same time* -- calls to mind an incisive observation about "the usual suspects" made by **The Great One** (*that's Hitler for you newbies and normies*) in Mein Kampf.

For one steeped in Real History, Cohn's con here truly is breathtaking. He argues that 2024 is similar to 1948 because -- although both years marked strong economies (*say what?!*) -- there was then, and is now, an irrational overreaction to inflation by stupid American voters. Even though, according to Commie Cohn, Truman was one of our "great presidents" and the economy was "strong," the Missouri miscreant barely won the election that year because rising prices had been blamed on him. Similarly, poor misunderstood "**Joe Biden**" is also unpopular due to inflation -- even though the economy is, according to Cohn, "promising."

We won't even address the absurd claim that the current inflationary and debt-drowning economy is "looking promising" -- except to say that during the post-World War II years, wages rose about as quickly as prices. Therefore, there was no net loss of purchasing power like there is now. To the contrary, due to factors having nothing to do with Truman, Americans of all classes would grow richer during the late 1940s and 1950s. Though the economic challenges of post-war reconversion did indeed dent Truman's popularity, that is NOT why he *barely* won in 1948.



Which lie is bigger? Cohn's characterization of Truman as a "great president" -- or his description of the current economy as "promising."

Truman became president in April of 1945 after the in-office death of **Franklin D. Roosevelt** at the start of his unprecedented 4th term. Cohn's omissions regarding Truman's unpopularity in 1948 are so glaring that they have to be deliberate. Here are some very important reasons for Truman's near-defeat in 1948 which Cohn did not mention:

* **The Iron Curtain** Although the post-war policy had been established by FDR's gang of Communists and Globalists, war weary Americans were incensed over the "Iron Curtain" which the Soviets had recently dropped across Eastern Europe during Truman's tenure. There was a sense that Stalin had eaten both FDR's and Truman's lunch during the historic conferences of 1945. (*Yalta & Tehran.*)

* **State of Israel** Truman's total subservience to the founders of the shitty little Zionist state may have earned him the positive press and the money of the usual suspects, but it was also perceived by many Americans that, in so doing, he needlessly created and linked us to a permanent problem in the Middle East. A few of the bolder critics, in condemning Truman's Zionism, even uttered the "J Word." *** Resumption of Chinese Civil War** Though it would not be until 1949 that China fell to Mao Tse Tung -- and 1950 until the Korean War broke out -- Americans were scratching their heads over how the Reds could have reemerged as a force in Asia. Though the betrayal of China was engineered at Yalta while FDR was president, Truman, having been FDR's VP, was also associated with the damage which the "blundering" policies were having in Asia.
